## Description of the study

Flinders University is undertaking a new national project to understand what Australians see as the pressing and complex issues or 'wicked problems' of our time.

Understanding our wicked problems — problems that are complex, open-ended and unpredictable and often require multiple and flexible solutions — is useful for the university in setting our research priorities and ensuring we are undertaking activities that align with community values and priorities.

The Wicked Problems Survey project comprises two phases:

- Phase 1: This phase of the study has been completed. During this phase, the research team conducted a series of focus groups and drop-in sessions with the general community to identify Australia's current wicked problems. These sessions were held across South Australia, including Port Augusta, Mount Gambier, and various northern, southern, and central suburbs of metropolitan Adelaide. In addition, interviews were conducted with government and non-government agencies to gather their perspectives on the complex challenges facing Australia. This phase also included a pre-test survey of 400 Australians nationwide, asking them to list their top 'wicked problems'. The data generated from Phase 1 were then combined and analysed to create a comprehensive and representative list of 'wicked problems' for inclusion in the Phase 2 survey.
- Phase 2: Your participation in this online survey will contribute to Phase 2 of the study. In this phase, researchers are conducting a national Wicked Problems Survey, in which about 30,000 Australians will be surveyed about their views on Australia's wicked problems identified in Phase 1. The Phase 2 survey will present you with a list of 'wicked problems' that have been developed based on conversations with the general community, as well as with people in government and non-government agencies who have a broad view of community issues in Australia. The aim of this study is to gather your opinions on these complex and pressing concerns that Australians have identified

as wicked problems, and to determine which challenges you consider most important for researchers to address.

## Benefits of the study

Sharing your thoughts will help us to understand the range and types of wicked problems people are concerned about. Furthermore, it will help us identify the most important issues to focus on in future research.

#### **Participant involvement**

You must be 18 years of age or older to participate in this research study.

If you agree to participate in the research study, you will be asked to:

- Complete an online survey. The survey will take approximately 10 minutes.
- Respond to questions that will help the research team identify and quantify the wicked problems concerning Australians.

## **Participant involvement**

We do not expect this research study to trigger any trauma; however, given the focus of the study being problems concerning you, there is a possibility that you may experience feelings of distress while answering some questions. ## Withdrawal rights

You may, without any penalty, decline to take part in this research study. If you decide to take part and later change your mind, you may, without any penalty, withdraw at any time without providing an explanation. To withdraw, you may refuse to answer any questions, close the internet browser, and leave the online survey. Data captured up until withdrawal may be used in the study.

#### Confidentiality and privacy

Only researchers listed on this form have access to the individual information provided by you. Researchers will take all possible steps to ensure privacy and confidentiality will be adhered to at all times. All of your answers will remain anonymous and your identity will be kept confidential.

The research outcomes may be presented at conferences, written up for publication or used for other research purposes as described in this information sheet. You will not be named, and your individual information will not be identifiable in any research products.

#### Data storage

The information collected will be stored securely on a password protected computer and Flinders University server throughout the study. Any identifiable data will be de-identified for data storage purposes. All data will be securely transferred to and stored at Flinders University for fifteen years from the date of publication of the results. Following the required data storage period, all data will be securely destroyed according to university protocols.

On project completion, a short summary of the outcomes will be made available via different media platforms and published on the Flinders University website. Participants can also request a summary of the
